Plat Review Checklist

Description

SKETCH PLAN: Subdividers may prepare a sketch plan for review by the Planning Commission. The sketch will be considered for informal discussion, only. No fee is required. The submission of a sketch plan does not constitute formal filing of a plan with the City. The Planning Commission will inform the subdivider of the extent to which the plan conforms to the Comprehensive Plan, design standards of this and other ordinances of the City, County, and State, and will discuss possible modification necessary to secure approval of the plan.

- _____ Title opinion or insurance title binder submitted by the owner/developer to the City Attorney for review
- _____ City submits plat to the County Recorder for review
- _____ Developer provide letter of credit or performance bond (100% of project cost)
- _____ City will disclose expenditure to complete infrastructure improvement
- _____ Public Hearing notice published in newspaper & sent to adjoining property owners
- _____ Planning Commission holds public hearing; recommends approval-disapproval-modifications to City Council
- _____ City Council meeting is held (approval-disapproval-modifications)
